I acknowledge that Entergy does not make any warranty or representation of any kind regarding the installation or implementation of energy efficiency measures, the benefits to be derived from the measures, or the fitness of the measures for the Project Site.

I acknowledge that prior to my signing a Customer Agreement with the Project Sponsor, the Project Sponsor provided, for my review, a copy of the Customer Disclosure Form approved by the Public Utility Commission of Texas (PUCT).

I acknowledge that I may file a complaint with the PUCT concerning the Project Sponsor, but that Entergy will play no role in resolving any disputes that arise between the Project Sponsor and myself.

I agree to provide Entergy or its representative and the independent measurement and verification expert selected by the PUCT, full and complete access to the Project Site for any purpose related to the Hard-to-Reach Standard Offer Program, upon three (3) days prior oral notice by the Project Sponsor.

I AGREE TO RELEASE ENTERGY FROM ANY AND ALL CLAIMS, DEMANDS, LOSSES, DAMAGES, COSTS, AND LEGAL LIABILITY INCLUDING, BUT NOT LIMITED TO (1) INJURY OR DEATH OF PERSONS, (2) DAMAGE TO NATURAL RESOURCES, (3) VIOLATION OF ANY LOCAL, STATE, OR FEDERAL LAW OR REGULATION INCLUDING, BUT NOT LIMITED TO, ENVIRONMENTAL AND HEALTH AND SAFETY LAWS OR REGULATIONS, (4) STRICT LIABILITY IMPOSED BY ANY LAW OR REGULATION, (5) EQUIPMENT MALFUNCTIONS, OR (6) ENERGY SAVINGS AND/OR DEMAND SAVINGS SHORTFALLS ARISING OUT OF, RELATED TO, OR IN ANY WAY CONNECTED WITH THE PROJECT, REGARDLESS OF ANY STRICT LIABILITY OR NEGLIGENCE OF ENTERGY, WHETHER ACTIVE OR PASSIVE.
